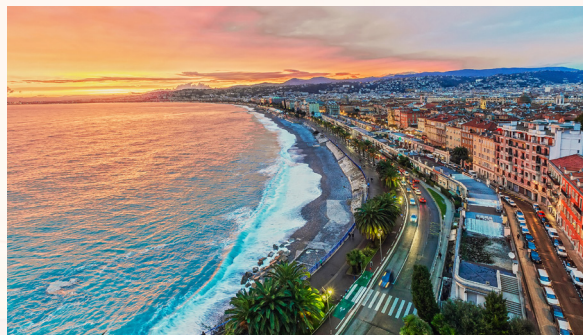

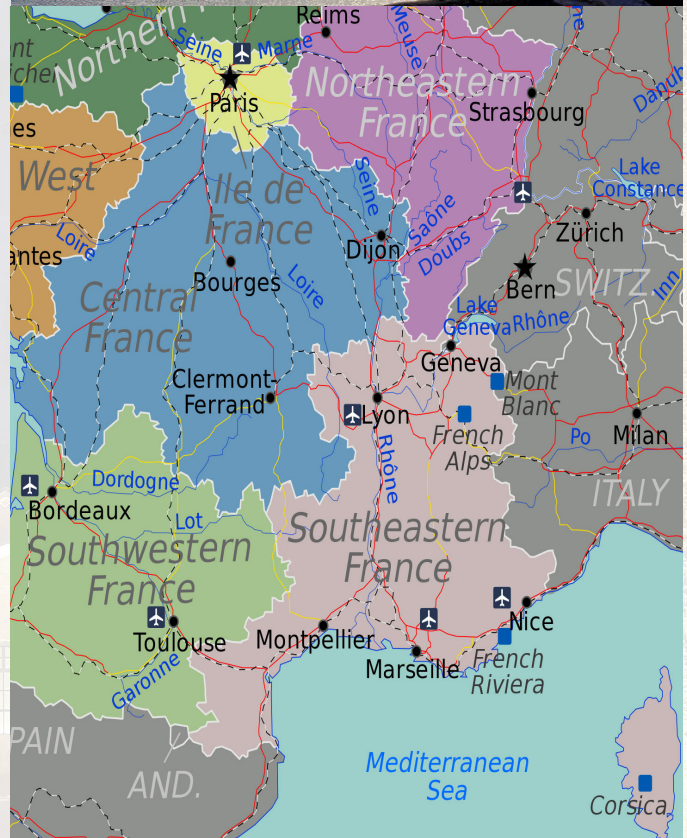
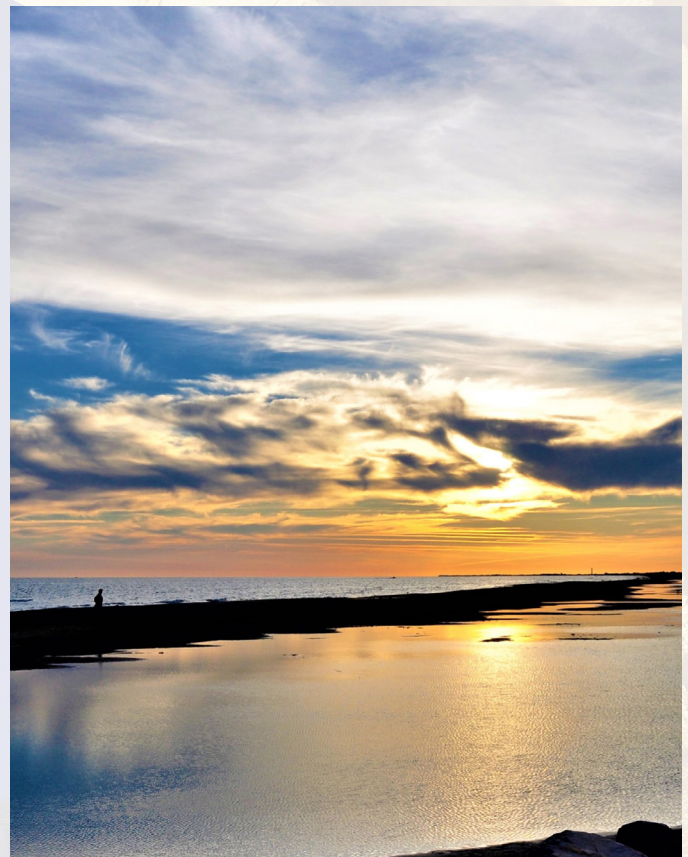

**VACCINATIONS.** Immunization requirements vary from country to country.
